What is Involved

understand that:

What I am Giving Up (What is being Released?)

- I am also giving them up with respect to any transportation or activities that take place off camp property.

Expulsion from the Camp

If I violate any rules of the Camp, or do anything that could put me or others at physical or emotional risk, I agree that this may result in immediate dismissal from the camp. I also agree that Camp management has sole discretion in making this decision.

Health

To my knowledge, I do not have a contagious illness and I am physically able to participate in all of the Program's activities. If there is any change in my health before the program begins, I will notify the Camp immediately.

Jurisdiction and Law

Any disputes that are connected to my participation in the Program will be litigated in the Superior Court of Ontario, in Ottawa, Ontario. They will not be litigated in any other court, city, province or country. The applicable law will be the law of Ontario.

Severability

If anything in this Form is found by a Court to be unenforceable, then it will be modified to reflect the parties' intention. Everything else in this Form will remain in full force and effect.
